#### **Licensures in Ontario**

Prior to registration with any of the provincial associations of architects in Canada, applicants must have their academic qualifications certified by the CACB (The Canadian Architectural Certification Board). Following certification of their academic qualifications, applicants are then required to complete the licensing requirements (including internship and exams) for the province in which they wish to register.

To have your professional architectural degree from another country certified, enabling you to practice as an Architect in Canada, you must follow the following steps:

Note: In Ontario; only individuals licensed by the OAA (Ontario Architects Association) may legally use the title "Architect".

### Step 1:

You must contact; The Canadian Architectural Certification Board.

The Canadian Architectural Certification Board certifies educational qualifications of graduates from professional University programs in architecture. The certification is a mandatory first step after graduation towards licensure and registration. Follow the link below

The CACB will review your transcript to determine the courses required to meet their accreditation requirements. Once notified, forward the course description from the University Calendar to the CACB contact.

#### Step 2:

You must register the course from one of Ontario universities such as University of Toronto, University of Waterloo, or Ryerson University Note: The course name is varied by Universities, for instance at The School of Architecture at the University of Waterloo, the course is named: Professional Practice (ARCH 655). #### There is a brief description of the course outlines:

Discussions of the legal and ethical aspects of architectural practice in Canada and in Ontario; in particular, contracts, bonds and insurance, construction lien, by-laws and regulations, architectural

partnership. The legal background, client-architect relations, partial services, professional problems.

The course is an introduction to the financial aspects of the development and construction industries.

The economics of property development and the process of cost estimation and control will be treated from a practical perspective.

The CACB will forward a letter or email verifying the acceptance of the course noted. This letter or email must be included with your application.

Note: The required course must be completed within 18 months after the documents submission to CACB. Check the course availability and your work timetable prior to submission of documents, otherwise you should redo whole process and pay new administration fee.

# Step 3:

After completing the mentioned course, and upon your request, the university will send a sealed transcript to the OAA. Coincidently, as an intern Architect you must apply for OAA membership.
